 - i. The LUT would like to begin mapping the condition (potholes, lighting) of the streets in Cherrywood for the benefit of pedestrians, cyclists, and drivers, based on submissions by residents.  - ii. The Permit Alert is back up but not working great, LUT members are working to fix

- iii. Girard is attempting to keep abreast of building projects in the neighborhood, but unless and until Permit Alert is working and LUT members are sending him current info about permit applications, many projects are missed.
